

# **RIGHT TO INFORMATION ACT, 2005**

## **Court Cases: In the following matters Board of Revenue is the Highest Court**

1. All cases relating to Excise.
2. Land Ceiling cases.
  - (a). Appeal Cases relating declaration of Surplus land.
  - (b). 16(3) Cases- Pre-emption case regarding sale of land.
3. Transport cases relating to cancellation of permit / Revision against the order of The Secretary, Transport.
4. Services Appeal – S.O. and Assistants of the joint Cadre for the Secretariat and in the office of Div. Commissioners.
5. Certificate appeal cases against order of collector under P.D.R. Act.
6. Registration – Appeal against order of I.G. Registration.
7. Appeal in mutation cases.
8. Cases under Bihar State Pollution Control Act.
